



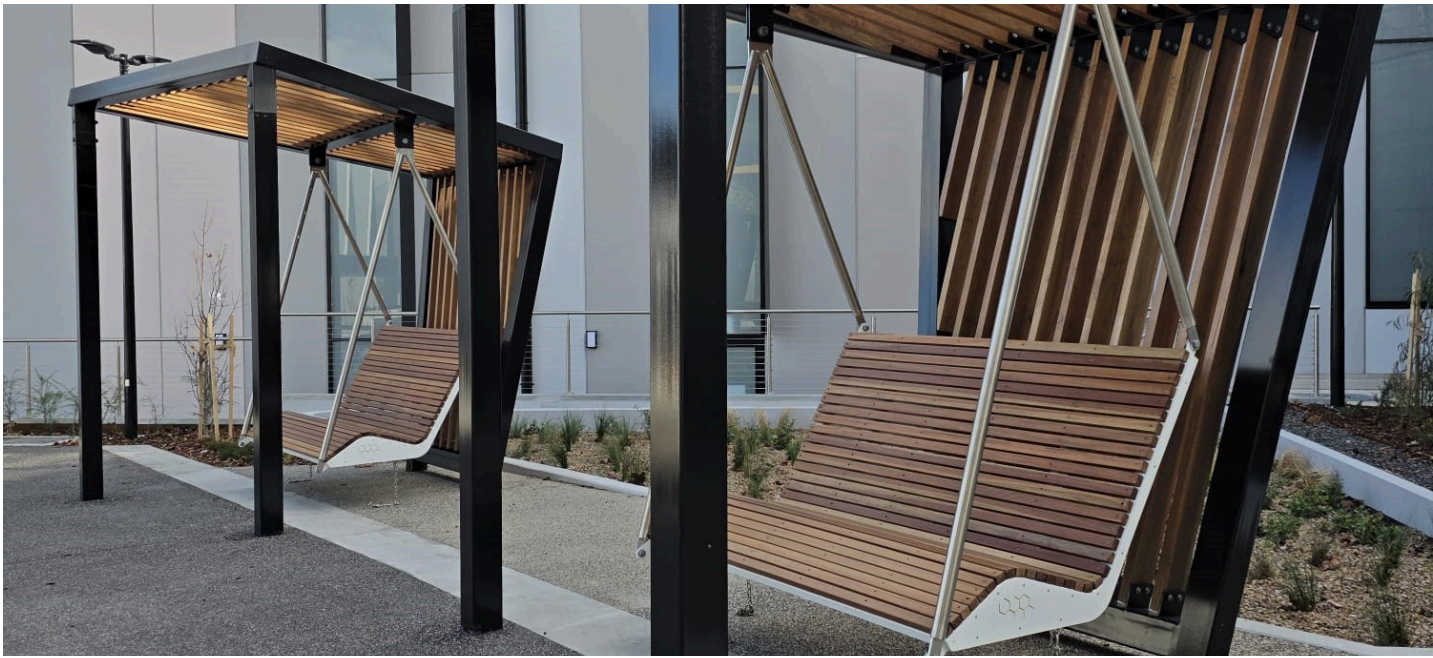

Our services include general & custom metal fabrications in one off or volume fabrications. Specialising in handrails, balustrades, staircases, architectural metal works & small to medium structural steel.

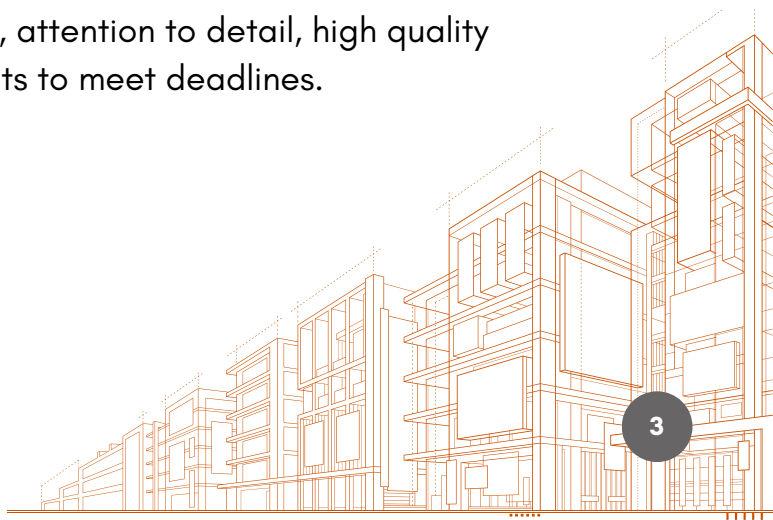
We offer all types of welding both in house & onsite, drafting, guillotine cutting, folding, laser cutting, powder coating & general engineering.

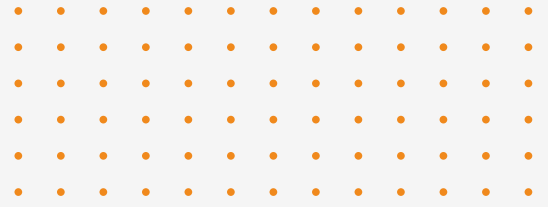

TERMS & CONDITIONS

Upon acceptance of this quotation, the works will be divided into the stages of shop drawings, material procurement, fabrication, and installation. Each stage constitutes a billable component, and an invoice will be issued upon completion of that stage in accordance with the payment terms.

GENERAL

All pricing is supplied as a packaged scope and is subject to shop drawing approval and final engineering.

Unless otherwise stated, no allowance has been made for engineering.

Pricing is subject to site conditions.

Reg 126 certification is available at an additional cost.

This quotation has been priced to complete the works in one stage. If the project is carried out in multiple stages, additional costs will apply for extra site visits and coordination.

If any items are removed, altered, or excluded from the packaged scope, the quoted price will be revised accordingly. Package pricing cannot be partially deducted without a formal re-quotation.

Lead times may be up to 3 weeks from approved shop drawings. Please contact us if express services are required, as surcharges may apply.

Berwick Fabrications is not responsible for any distortion or damage caused by galvanizing or external contractors.

Custom orders cannot be cancelled once manufacture has commenced.

Stocked items only may be returned within 7 days and must be in prime condition. A 25% restocking fee may apply.

Non-stocked and custom items cannot be returned for credit.

CLIENT-SUPPLIED INFORMATION & SITE REQUIREMENTS

Estimates are based solely on details provided by the client. Please ensure that all information included in this quotation aligns with plans and specifications prior to placing an order.

The builder must supply slab mark-out and grid lines to work from.

The builder must also ensure all required back-blocking is installed prior to installation.

Berwick Fabrications will not be responsible for any incorrect or incomplete information supplied by the client, nor for variations arising from such inaccuracies.



TERMS & CONDITIONS

SHOP DRAWINGS, DRAFTING & DESIGN

Shop drawings form a billable component of this quotation.

All drafting will be completed based on the customer's initial request and supplied documentation.

Any changes made after receipt of the original order specifications will require redrafting and will be charged at an hourly rate.

Quotation includes:

- 1 site measure
- 1 set of shop drawings
- 1 revision

Additional revisions, site visits, design changes or clarifications are charged at an hourly rate, which will be discussed at the contracting stage.

Drafting and Design Consultation, including where supplied drawings are unclear or insufficient for fabrication, is charged at an hourly rate.

SHOP DRAWING FEE & INTELLECTUAL PROPERTY

Payment for shop drawings becomes due upon delivery of drawings, regardless of whether the project proceeds to fabrication or installation.

All drawings remain the property of Berwick Fabrications Pty Ltd until full payment is received.

Drawings issued prior to payment will be marked "Issued for Review Only - Not for Construction" and may not be used, reproduced, or issued to third parties until paid in full.

VARIATIONS

Any variations to the quoted scope, including additional drafting, redesign, engineering changes, staging requirements, site visits, material changes, or instructions outside the original specifications, will be invoiced separately.

Variations are subject to the same payment terms as the original quotation.



TERMS & CONDITIONS

PAYMENT TERMS

A 20% deposit is required from all new clients and builders prior to the commencement of shop drawings or procurement of materials.

Invoices will be issued for each billable stage, including shop drawings, material procurement, fabrication, and installation. Each stage may be invoiced prior to overall project completion.

For existing clients and builders, payment terms are strictly 30 days End of Month (EOM).

Goods remain the property of Berwick Fabrications Pty Ltd until full payment is received.

Overdue accounts may result in work being paused until payment is received.
